## OFFICIAL 2019 CONTEST RULES

## **Qualified Participants:**

The Law Day Contest is open to students attending a public or private school, or being home schooled, within the San Bernardino County and in **grades 6-8** or the equivalent.

## **Essay Theme: Separation of Powers**

Write an essay of no more than 500 words that covers the topic:

**Introduction:** The First Amendment of the Constitution of the United States of America states: "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

Topics: Why did our Founding Fathers believe free speech and free press were important? Do you think there should be any limit(s) on your constitutional right to speak? How might our lives be different today if the Constitution did not include these rights?

### **Steps to Enter:**

- 1. Read and agree to the contest rules.
- 2. Write the essay.
- 3. Email the essay to <u>BLee@sb-court.org</u> or mail the essay using the mailing instructions included below

#### **Contest Deadline:**

Contest entries will be accepted beginning **February 18, 2019**. To be eligible for prizes, all entries must be uploaded or postmarked by **April 15, 2019**.

#### **Contest Prizes:**

Prizes will be awarded for each division as follows:

1<sup>st</sup> Place and Overall Winner: Inscribed plaque presented to student by a Judge from the San Bernardino Superior Court

2<sup>nd</sup> Place: Inscribed plaque

3<sup>rd</sup> to 5<sup>th</sup> Place: Honorable Mentions

Selection of winners and runners-up will be based on originality, creativity, adherence to the theme, and overall quality. With the permission of the winning students, their essays may be reproduced in local papers and may be used to promote Law Day 2020!

## **Essay Specifications:**

Essays must be a maximum of 500 words.

Essays must be submitted in **PDF or word format**.

All essays must be submitted in Times New Roman, 12 point font.

Essays may not incorporate any copyrighted characters (i.e. comics and/or television characters), photographs, and magazine or newspaper illustrations.

Essays must be original, correct in safety concepts, and the exclusive work of the student entering the contest in idea, design, and execution.

Submissions will not be accepted or eligible if they include- in the sole judgment of the committee- any content that contains or appears to contain:

- 1. Profane, obscene, or inappropriate material
- 2. Inappropriate language
- 3. Any derogatory characterization of any person or group based on age, race, color, gender, gender identity, citizenship, creed, national origin, physical appearance, political affiliation, union membership, or other unethical or lawful factors
- 4. Any actual or apparent copying or other infringement of another's intellectual property rights There must be a cover page to each submitted essay which includes the student's name, grade, age, teacher's name, school name, and school address. An example of necessary information is included at the end of the contest rules.

All expenses involved in preparing and submitting an entry are the entrant's responsibility.

## **Contest Infrastructure:**

The San Bernardino Superior Court Essay Contest is sponsored by the San Bernardino Superior Court. The San Bernardino Superior Court Judicial Outreach Committee will select one winner and four runners-up from among the eligible entries that, in the sole discretion of the committee, meet the minimum quality standards and best reflect the theme. Winners will be announced on or about **May 1, 2019**.

All essays and related intellectual property rights become the property of the San Bernardino Superior Court upon receipt and are not returned to the author, his/her parents/legal guardians, instructor/teacher, school, state, or any other person(s) claiming a right, title, or other interest in the essay.
